"A Different Kind of Hero......" Reflections 2004-2005

The Reflections program started in 1969 in Colorado and is one of the most popular offerings from the National PTA. The program provides opportunities for students to express themselves through the arts. Students compete in the following four categories:

- Musical Composition
- Photography
- Literature
- Visual Arts

Each PTA unit should have a Reflections chair. This individual can work with his/her fine arts instructors in his/her school. The goal is to have as many students participate as possible. The classroom or language arts teachers should also be encouraged to have their students write poems or short stories for the literature category. Students may wish to do a drawing for the visual arts category. Each piece of work should go along with the theme for this year (A Different kind of Hero). Please consider having an "Evening for the Arts" at your school to display the entries. A certificate could be presented to each participant.

It is imperative that the individual Reflections chairs receive a copy of the information. Specific guidelines for each category. The checklists for each category are very helpful. As always, there are changes and/or modifications in this year's rules. Entries continue to be disqualified at the state level for failure to follow specific guidelines.

Each school may submit a **maximum of three entries in each category** for the state competition. The entries will be due in Mr. Tom Schneider's office (925 Felix – first floor [second level]) on Friday, January 14, 2005. Each entry must have the proper Official Entry Form completed. The form requires certain signatures, "Pony Express" Council or region, bylaws review date and the National PTA identification number. Each school will also have a Participation Form A to complete with entry totals and number of students enrolled in the school. Note that each submitting unit **must have current PTA bylaws** and **have paid at least some monies to the state organization**. This is another common reason for disqualification of entries.

The St. Joseph PTA Council mails/delivers the schools' winning entries to Columbia, Mo. PTA units must not mail their entries directly to Columbia. The Council Reflections chair will carefully review all of the entries to be sure all the rules are met before mailing to the state Reflections chair. Participants need to type or print all entry forms in blue or black ink.

There will be a Reflections evening in late April or early May to honor students who were winners at their school as well as those who have won at the state and national levels. Students who receive recognition will not have their entries returned until following the 2004 fall PTA convention where the entries will be displayed. (Literature and music entries are not returned. Be sure to make a copy before submitting them). Diana Slawson (233-0627 or slawson@stjoelive.com) is the local Reflections chair and will be glad to help. The Missouri PTA office (1-800-328-7330) is another good resource. This is a wonderful opportunity for our students to use their imaginations and creativity. Here is a chance to involve your artistic but organized volunteers! Have fun with this activity. Don't wait – get your volunteers and teachers started today.

Don't worry--we'll clean it up together.


I'm so proud of you!

Davis-Langemach PTA Council Award of Excellence

Background

The "Davis-Langemach PTA Council Award of Excellence" is named after Mrs. True Davis, Sr., and Mrs. Vernon Langemach, both highly admired St. Joseph ladies, who are past State PTA Presidents.

Determination of Winner

The administrator, teacher, or staff member, who has been nominated, must have made a major difference in the life of a student of the St. Joseph School District. It should be something that will be of major impact in the child's life and must have taken place between the first day of school and the last day of school.

A nomination may be made by a parent/family member, administrator, teacher, staff person, or other adult community member. (No self nominations please.)

The administrator of the nominee as well as the nominating party must sign the form to assure validity.

Each month one winner will be selected and recognized by the St. Joseph PTA Council. The winner will be awarded a certificate of recognition. In addition, a book valued at \$25 will be given in honor of the winner to the school where they are employed. If they are not employed at a school, then they may select which school will receive the book.

An impartial panel of three individuals will determine the winners. The panel will include a school district official, a PTA Council representative, and a local parent.

Nominations submitted will be kept for consideration for that school year unless they are chosen as a winner.

The child's name will not be released to the public.

In order to be considered as the next month's award recipient, three copies of the nomination must be received by the 20th of the previous month. The first award will be in September.

St. Joseph PTA Council Legislation Committee 2004-05 Program of Work

As Chairperson of the St. Joseph PTA Council Legislation Committee for the 2004-05, under the Department of Promotion, I plan to participate in the following activities for the year:

- 1. Promote the "**Declare Yourself VOTE**" campaign to encourage people to register to vote, learn about candidates, and vote.
- 2. Support St. Joseph School District issues that affect education such a levy, bond, or other similar issues.
- 3. Serve as a member of the Missouri PTA Legislative Network where I will respond to requests for action by Missouri PTA and contact appropriate state or national representatives or senators. In addition, promote that others be an active network member.
- 4. Attend the annual Missouri PTA Legislative Rally or other rallies held in Jefferson City, Missouri, and advocate for PTA issues while visiting the offices of our area State Senator and State Representatives.
- 5. Attend the St. Joseph Regional MSTA/Classroom Teachers' Association monthly Legislative Forums, held January through April at Hillyard Technical Center, serving as a greeter or moderator as needed.
- 6. Attend the annual Northwest Missouri/Kansas City MSTA Legislative Brunch held in at the Hilton Inn at the Kansas City International Airport.
- 7. Prepare articles for the **St. Joseph PTA Council Clippings**, as needed.
- 8. Report legislative information at the local St. Joseph PTA Council meetings.
- 9. Provide legislative guideline information sheets to be distributed at the St. Joseph PTA Council School of Information.
- 10. Visit the offices of United States Senators and our Congressman to promote educational legislation and issues while in Washington, DC, March 6-8, 2005.
- 11. Email, write, fax, or call my state and federal representatives and senators as needed regarding issues concerning education or children, as needed. Encourage other PTA members to also communicate with officials.
- 12. Register Buchanan County residents to vote, as needed.
- 13. Attend political activities to hear and ask opinions of potential candidates and elected candidates of their positions on education-related issues.
- 14. Invite legislators to visit and tour St. Joseph School District facilities.
- 15. Assist with other activities as assigned by the PTA Council President.

Declare Yourself



Declare Yourself is a national nonpartisan, nonprofit campaign to energize and empower a new movement of young voters to participate in the 2004 presidential election. It includes an unprecedented nation-wide voter education initiative for high school seniors; a comprehensive voter registration and election information Web site; a massive voter registration drive, and public service announcements. The intent is to ignite millions of young voters. The website is **http://www.declareyourself.com**.

Our goal as PTA leaders is to inspire students to declare themselves and get involved in the voting process. As leaders we want to do such things as:

- Hold a voter registration day and make it a special event for the student/individual registering.
- Serve as a voter registrar at your school.
- Wear a pin signifying and reminding students of the importance of voting.
- Invite legislators into your building.
- Have your students email or fax their opinions regarding current issues or bills to their senators and representative's office (both state and federal).
- Make announcements at your school of registration deadlines, dates to vote, etc.
- Encourage students to Absentee Ballot if they are unable to vote at the regular time.
- Allow students to access the *Declare Yourself* website and read about current issues in the presidency

The campaign was founded by Norman Lear, TV producer and philanthropist. The campaign is supported by Home depot, the United States Postal Service, AXA Financial, Inc., Yahoo!, ClearChannel, and others. The goal of Declare Yourself is to teach young people—particularly those eligible to vote for the first time, every piece of information he/she needs to know:

- How to register to vote
- When and where to register
- How to get information about absentee ballots
- How to become and stay informed about campaign issues
- How to find his/her polling place
- How to VOTE on Election Day

As PTA leaders, we want to inspire our students to get involved, participate in the process, be informed, and vote in each election. We want to increase the percentage of voting eligible Americans. EVERY VOTE COUNTS.
